### Important information

- Each person occupying a pitch is responsible for sorting their refuse and placing it in the bins provided for this purpose.
- Animals must be kept on a lead and must perform their natural functions outside the campsite
- ABSOLUTE QUIET IS REQUIRED FROM 11 PM TO 8 AM
- The maximum speed within the campsite is **10 Km/hr** between 7 AM and 11 PM for reasons of child safety
- **For reasons of security (of people and possessions) all visitors must inform reception of their arrival**
- Parents are responsible for their children, especially in the games area
- **Naked flames and the lighting of barbecues (except gas ones) is strictly forbidden (there are several communal barbecue areas around the camp).**

Failure to respect these few simple rules will mean that the offender will be warned. If it happens again he/she will be asked to leave.

## RENTAL CONTRACT FOR CAMPING PITCH

1 - Please read and complete this contract very carefully, as our planning is based on specific dates. Return it together with a deposit of 50€, a letter confirming your reservation will be sent to you.

2 – You will be charged for your stay from the day you state you will arrive to the departure date as written in this contract (even if you advise us that you will be late in arriving).

3 – If you cancel your stay : You must write it and send it to us.

- Before the 1<sup>st</sup> of May, your deposit will be refunded totally.
- Between the 1<sup>st</sup> of May and the 15<sup>th</sup> of June, refunded will be 50% of you deposit.
- From the 16<sup>th</sup> of June, the deposit will be kept by the campsite.

4 – Pitches are rented from noon until noon.

5 – In the case of an anticipated departure that does not respect the reserved period, the client will lose his deposit up to a maximum of 50 €.

6 - If a friend or member of your family wishes to contact you by telephone during your stay with us please inform them that reception will only take messages (except in emergencies). You could arrange a time for them to call you at the reception.

7 - The deposit can be sent in the form of a bank cheque or “Cheques Vacances”.

8 - Animals will only be admitted on presentation of a valid vaccination card and if they are kept on a lead.

9 - It is agreed that the campsite and its manager cannot be held responsible in cases of accident or injury that may occur to yourself or one of the members of your group whatever the cause. The same applies to loss, theft or damage caused during the rental period (NB: please make a note of the name and address of your civil liability insurers, just in case).
