**On your arrival, you will be asked to pay the remainder of the rental fee, as well as a deposit of 100 € per caravan or 200 € per mobile home, which will be given back to you on your departure if there is no damage to the caravan/mobile home and the caravan/mobile home is in the same state of cleanliness as at your arrival, inclusive of crockery, kitchen equipment, fridge and floor. If this is not the case, the cleaning costs (50 €) or repair costs (estimate total) will be deducted from the deposit.**

## **RENTAL CONDITIONS**

**1 - Please read and complete this contract very carefully, as our planning is based on specific dates. Return it within a fortnight, if you want to guarantee the caravan/mobile home.**

2 – All rentals are non-transferable and cannot be sub-let.

3 – If there is no message from the contract holder, stating that he has had to defer the date of arrival, the rental will become available 24 hours after the date of arrival contained in the contract and payment in full for services will be required.

4 – If you cancel your stay : You must write it and send it to us.

- Before the 1<sup>st</sup> of May, your deposit will be refunded totally.
- Between the 1<sup>st</sup> of May and the 15<sup>th</sup> of June, refunded will be 50% of you deposit.
- From the 16<sup>th</sup> of June, the deposit will be kept by the campsite.

5 - The cost of any stay that has already commenced is due in its entirety based on the dates indicated in this request. There will be no reimbursement in cases of premature departure.

6 – All rentals will be available from 2 PM on the day of arrival and must be vacated by 12 noon on the day of departure, or 10 AM if you have selected the day of departure cleaning option.

7 – You can park your car on your pitch. If you want to park an additional vehicle, see tariff.

**8 – The pets are forbidden in rental caravans and mobile homes.**

9 – The deposit can be sent in the form of a bank cheque or “Cheques Vacances”.

10 – It is agreed that the campsite and its manager cannot be held responsible in cases of accident or injury that may occur to yourself or one of the members of your group whatever the cause. The same applies to loss, theft or damage caused during the rental period (NB: please make a note of the name and address of your civil liability insurers, just in case).
